



Lease Agreement

This is to advise the lease terms and conditions of the equipment that will be supplied to you by Pacific Vision. Following are the terms and conditions of this lease. It is important that you read and understand these conditions. By signing your name to this agreement you agree to be bound by these terms and conditions.

Where in this document the word "we" is used, it refers to us, Pacific Vision International Ltd. and where the word "you" is used it refers to you, the person hiring the equipment.

The hire of the equipment will be for an indefinite period of time, commencing on ___/___/2010. The hire can be terminated at any time by either of the parties. After five years (60 months) the unit will be replaced by a more recent unit. Alternatively you can cancel the lease after 5 years and the unit becomes your property. If the unit becomes your property, you are responsible for any repair and or maintenance costs. Within the rental period the equipment remains our property and should be returned to us when it is no longer needed by you or upon request.

Lease payments are collected by way of an automatic payment authority. Please complete the banking details (account number, bank and branch) on the enclosed bank authority form, sign it and return it to us in time for the first lease payment to commence.

You will not use the equipment other than for the purpose for which it was designed, will not make alterations or modifications and shall not under any circumstances use the equipment for any illegal activity. Penalty for this is that this agreement shall be deemed to be terminated, and the equipment must be returned to The Owner where a penalty may apply of one year's rental to cover costs. Also, you will not sublet, lend or sell the equipment to anybody else. Nor will you mortgage, charge, pledge or part with the equipment.





You shall protect the equipment against distress, execution or seizure and shall indemnify us against all losses, damage, costs, charges and expenses arising as a result of any failure to observe and perform the terms and conditions of this contract. You will insure the equipment against loss, theft or damage at the replacement value through your house contents insurance.

You shall ensure that all reasonable care is taken in handling maintaining and cleaning The Equipment and that it is kept secure at all times. Also you shall not remove, deface or cover up any nameplate or identification mark or number on the equipment, nor shall any mark be put on the equipment which might indicate or suggest that the equipment is not the property of Pacific Vision.

We shall not be liable for any consequential damage, injury or loss suffered by you as a result of the equipment breaking down during the period of hire. We are not responsible for injury to persons or property caused by the use of the equipment.

When the equipment breaks down or works unsatisfactory, please contact us as soon as possible and do not attempt to repair the equipment yourself. If we can't repair the equipment, we can substitute it with equipment of a similar type. If we are not able to do so, the hire shall be terminated as from the date of notification of the breakdown. If the equipment breaks down due to misuse by you, you shall be chargeable with costs of repair and transport for the equipment. We can choose to replace the unit for a more recent one if we feel that possible repair cost may influence the value of the unit negatively.

You acknowledge that we, have instructed you in the safe use and operation of the equipment supplied and that it will be used only in accordance with those instructions. You also acknowledge that you received the equipment in good working order and clean condition and acknowledges it is fit for the purpose for which it is let on hire.





You acknowledge that if you fail to keep up with your monthly payments or if you fail to observe and perform the terms and conditions of this contract, Pacific Vision at its discretion may repossess the lease equipment without notice and you shall be liable for all costs incurred in this process.

You agree to notify Pacific Vision of any changes to your contact information.

You should note that because of your circumstances, you are not eligible for funding via the Ministry of Health funding scheme, as your circumstances do not meet with their funding criteria. However, please note that you may be eligible for assistance towards meeting the cost of the rental of a CCTV through the Disability Allowance provided by Work and Income New Zealand.
